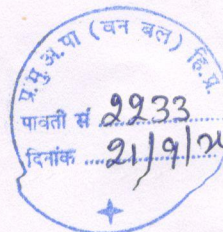

**Subject:-** Diversion of 0.9785 ha. of forest land in favour of Department of Tourism & Civil Aviation, Himachal Pradesh for the Construction of a Heliport at Rakkar in Tehsil Dharamshala, within the jurisdiction of Dharamshala Forest Division, Distt. Kangra, Himachal Pradesh.-Reg.

भारत सरकार, पर्यावरण, वन और जलवायु परिवर्तन मंत्रालय, क्षेत्रीय कार्यालय, चंडीगढ़, उप-कार्यालय शिमला द्वारा वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा-2 के अन्तर्गत जारी स्वीकृति पत्र संख्या Online Proposal No. FP/HP/Others/411333/2022 दिनांक 04/09/2024 के परिणामस्वरूप, राज्यपाल, हिमाचल प्रदेश उपरोक्त विषय में दर्शित 0.9785 है० वन भूमि के गैर वानिकी उपयोग के लिए विधिवत् स्वीकृति (Final Approval) निम्नलिखित शर्तों पर प्रदान करते हैं:-

**1.General Conditions:-**

1.1	<ol style="list-style-type: none"><li>1. Legal status of the forest land shall remain unchanged.</li><li>2. The number of trees/plants to be felled shall not in any way exceed the number indicated in the proposal and no harm shall be done to the wildlife during felling of trees. The felling of trees/plants will be carried out under the strict supervision of the State Forest Department and the amount spent on felling of trees/plants will be deposited by the user agency to the State Forest Department.</li><li>3. As per the proposed CA Scheme, Compensatory afforestation (CA) shall be taken up by the State Forest Department over degraded forest land in <b>1.96 ha, Block/Compartment No-UP 140K, Charri C-5, Dharamshala Forest Range, Dharamshala Forest Division, District Kangra</b> at the cost of the user agency. The Plantation shall be done within one year from the date of issue of approval. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall strictly be avoided.</li><li>4. The Divisional Forest Officer shall ensure that the approved CA will not be changed without the approval of Competent Authority.</li></ol>





5. The Nodal Officer (State CAMPA) Authority shall ensure that the funds under State CAMPA will be released to Divisional Forest Officer as per approved CA scheme.
6. The State Forest Department shall upload the KML files of the degraded forest area accepted for raising compensatory afforestation in the *E-Green watch portal of FSI*, before handing over of forest land to the user agency.
7. The initial permission will be given to this proposal for **99** years. After that the permission shall again be obtained from the Government of India. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
8. The forest land shall not be used for any purpose other than that specified in the proposal.
9. The user agency shall pay additional amount of NPV as and when increased by the order of Hon'ble Supreme Court and the State Forest Department will ensure that the increased amount is deposited.
10. No kind of damage will be done to the adjoining forest land. Simultaneously, all efforts will be made to save adjoining forest and forest land.
11. The forest land proposed to be diverted shall, under no circumstances, be transferred to any other agency, department, or person without approval of the Central Government.
12. The layout plan of the proposal shall not be changed without prior approval of Central Government.
13. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
14. The user agency shall carry out muck disposal at pre-designated sites as per the scheme approved.
15. Any other condition may be stipulated by the regional office from time to time, in the interest of conservation, protection and development of forests & wildlife.
16. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
17. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per para 1.16 of the consolidated guidelines and clarifications on Van (Sanrakshan Evam Samvardhan)

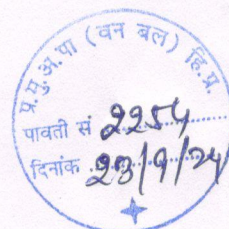


