Applications are invited from eligible retired officials for re-engagement on a remuneration basis against the vacant posts of Patwari under the establishment of the Wildlife Circle (North) Dharamshala, HP.

The interested retired officials may submit their applications exclusively for the post on the prescribed format along with self-attested copies of all relevant documents/certificates, i.e. proof of date of birth, proof of retirement, experience mentioning length of service in the revenue department and other supporting documents. The detailed terms and conditions are appended herewith.

Essential qualifications for the post of Patwari	The applicant must be a retired official of any wing of the Revenue Department, Himachal Pradesh, having rendered a minimum of five years of service. No departmental, disciplinary, or vigilance proceedings should be pending or contemplated against him/her at the time of consideration for re-engagement.	
Age	The retired officials to be considered for re-engagement should not have attained the age of 65 years as on the date of publication/advertisement of the vacancies.	
Place of posting	(01 No.) in the office of DFO Wildlife Division Hamirpur having jurisdiction of Dhauladhar Wildlife Sanctuary and Pong Dam Wildlife Sanctuary and (01 No.) in the Office of Wildlife Division Chamba having jurisdiction of Kugti Wildlife Sanctuary, Kalatop-Khajjiar Wildlife Sanctuary, Gamguel Siyabehi Wildlife Sanctuary, Sechu Twan Wildlife Sanctuary and Tundah Wildlife Sanctuary.	

Re-engagement of retirees will be made on following Terms & Conditions :-

1. The retired official shall be re-engaged for 1 year in the first instance. The period of re-engagement may be extended further depending upon the performance of the candidate & the requirement.
2. The applicant must have rendered minimum 5 years of service in any wing of revenue Department of HP before their superannuation and having no departmental /disciplinary proceedings pending against them.
3. The applicant shall be considered for respective post on the recommendations of the committee.
4. The retired official to be engaged shall not be more than 65 years of age on the date of advertisement of vacancies.
5. If the applications exceed the number of vacancies advertised, the candidates who are junior in age shall be given preference for re-engagement against such post.
6. The period of re-engagement shall not be counted for any benefits whatsoever in the service rendered by the applicant before his superannuation.
7. The re-engagement of retired official shall be purely on temporary basis and is liable to be terminated at any time during the period of such re-engagement.
8. The retired official to be engaged shall be entitled for one day casual leave after putting one month service. No leave of any other kind shall be admissible to him/her.
9. Unauthorized absence from the duty without the approval of the controlling officer shall automatically lead to the termination of such re-engagement. They will not be entitled for emoluments for the period of absence from duty.
10. The applicants are required to produce certificate of fitness issued by competent authority of Govt. Hospital.
11. They will be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counterpart officials at the minimum of pay scale.
12. He/She shall continue to avail medical facilities and re-imbursment of Medical Expenses as admissible to him/her as a retiree.
13. The monthly remuneration shall be paid to the re-engaged retirees on the basis of performance/work conduct to be monitored on the monthly basis

by the Controlling Authority.

14. The promotion of existing Patwaris shall not be affected on account of re-engagement of above retirees & the posts occupied by them will be considered vacant for the purpose of promotion.

15. Their re-engagement is liable to be terminated on availability of regular officials.

16. The services of the re-engaged retired revenue official is liable to be terminated with immediate effect in case he is found involved in any immoral, unethical or corrupt practice.
