In exercise of the powers conferred by sub-section 5(2) of The Wildlife (Protection) Act, 1972. The Chief Wildlife Warden, Himachal Pradesh with the prior approval of the State Government of Himachal Pradesh vide its letter No. FFE-B-A (3)2/1998 dated 24.07.2018 hereby, delegates his powers and duties under different sections of this Act as specified in column 2 & 4 to the Authorized Officers mentioned in column 3 of the following Table within the area of their jurisdictions with immediate effect:-

1	Section 27 Sub-section 1 clause (c)	Chief Conservator of Forest/Conservator of Forest/Deputy Conservator of Forest/Divisional Forest Officers.	Taking charge of any dead wild animal.
2	Section 28 Sub-section 1 clause (d)	Chief Conservator of Forest/Conservator of Forest/Deputy Conservator of Forest/Divisional Forest Officers.	Grant of permit to enter a Wildlife Sanctuary for tourism.
3	Section 35 Sub-section (8)	Chief Conservator of Forest/Conservator of Forest/Deputy Conservator of Forest/Divisional Forest Officers.	Taking charge of any dead animal in any National Park.
4	Section 35 Sub-section (8)	Chief Conservator of Forest/Conservator of Forest/Deputy Conservator of Forest/Divisional Forest Officers.	Grant of permit to enter a National Park for tourism.


