Subj:- Renewal of existing mining lease and installation of Stone Crusher for a period of fifteen years w.e.f. 20th November, 2010 to 19th November, 2025 for diversion of 0.93 hectares of forest land in favour of Sh. Sachin Sood S/o Late Sh. Ashok Kumar Sood, Prop. M/s Himalayan Stone Crusher and Quarry R/o Village Chuhabag, P.O. Khaneri, within the jurisdiction of Rampur Forest Division Rampur Bushahr, Distt. Shimla, Himachal Pradesh.

भारत सरकार पर्यावरण एवं वन मन्त्रालय उत्तर क्षेत्रीय कार्यालय चण्डीगढ़ द्वारा वन (संरक्षण) अधिनियम 1980 की धारा-2 के अन्तर्गत जारी स्वीकृति पत्र संख्या 9-HPB199/2011 - CHA दिनांक 30-04-2013 के परिणामस्वरूप राज्यपाल, हिमाचल प्रदेश सरकार द्वारा 0.93 hectare of forest land in favour of Sh. Sachin Sood S/o Late Sh. Ashok Kumar Sood, Prop. M/s Himalayan Stone Crusher and Quarry R/o Village Chuhabag, P.O. Khaneri, within the jurisdiction of Rampur Forest Division Rampur Bushahr, Distt. Shimla, Himachal Pradesh को उपयोग के लिए निम्नलिखित शर्तें पूरी करने पर प्रदान की जाती है।

1. Legal status of the forest land will remain unchanged;
2. No tree felling is involved in the case;
3. Mining lease is renewed for a period of fifteen years from the date of expiry of previous lease period i.e. from 20th November, 2010 to 19th November, 2025;
4. The conditions stipulated while giving approval under the Forest (Conservation) Act, 1980 for diversion/renewal of lease of forest land for mining purposes shall be monitored as per Para 4.16 (ii) & (iii) of the guidelines issued under forest (conservation) Act, 1980;
5. There will be regular monitoring by the forest department for compliance of conditions including the quantity extracted;
6. The operation of mine should be as per the approved mining plan and user agency shall submit annual self compliance report to the authority concerned;
7. Dumps will be used locally behind retaining walls depression/improvement of grades. It will in no way be thrown down the hill slope and will also not be thrown in nullahs, etc. and shall be reclaimed;
Reclamation of mined area shall be done at the cost of user agency as per proposed scheme. Reclamation work will be taken up after the expiry of this extension or if possible, before that in part of the area;
9. Demarcation of lease area to be done on the ground at project cost using four feet high reinforced cement concrete pillars with serial numbers, forward and back bearings and distance from pillar to pillar;

- 10 No damage of any kind will be caused to the adjoining forest area and all the protection/precautionary measures for stability of the forest area be strictly adhered to;
- 11 Safety Zone/Area treatment Plan will be implemented as per the proposal;
- 12 NOC from HPPCB and other department/offices shall be obtained by the user agency;
- 13 The forest land will not be used for any purpose other than that specified in the proposal;
- 14 An undertaking from the user agency to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India;
- 15 Environment clearance has also to be obtained in this case in view of the Hon'ble Supreme Court order dated 27.02.2012 in IA No. 12-13 of 2011 in SLP (C) No. 19628-19629 of 2009;
- 16 It will be the responsibility of the User agency to obtain prior approval/clearance under all other relevant Acts/rules/Court's rulings/instructions etc. as applicable to this proposal.
- 17 A lease-deed of the forest land shall be executed by the user agency with Collector-cum- Deputy Commissioner, Shimla District Shimla, HP.
