Sub:- Renewal of existing mining lease (Extraction Slates) for a period of five years w.e.f. 5th November, 2011 to 04th November, 2016 for diversion of 1.3950 hectares of forest land in favour of M/s Himachal Slate & Stone within the jurisdiction of Chamba Forest Division, Distt. Chamba, Himachal Pradesh.

भारत सरकार पर्यावरण एवं वन मन्त्रालय उत्तर क्षेत्रीय कार्यालय चण्डीगढ़ द्वारा वन (संरक्षण) अधिनियम 1980 की धारा-2 के अन्तर्गत जारी स्वीकृति पत्र संख्या 9-1209/2001-ROC दिनांक 28-05-2013 के परिणामस्वरूप राज्यपाल, हिमाचल प्रदेश द्वारा 1.3920 hectares of forest land in favour of M/s Himachal Slate & Stone within the jurisdiction of Chamba Forest Division, Distt. Chamba, Himachal Pradesh को उपयोग के लिए निम्नलिखित शर्तें पूरी करने पर प्रदान की जाती है।

- 1 Legal status of the forest land will remain unchanged;
- 2 No tree felling is involved in the case;
- 3 This approval is valid for a period of Five years from (05th November, 2011 to 04th November, 2016)- the date of issue of this letter or coterminous with mining lease whichever is earlier;
- 4 The mining is open cast for extraction of slates. No blasting in the area shall be done and no damage will be caused to the adjoining forest area;
- 5 The conditions stipulated while giving approval under the Forest(Conservation) Act, 1980 for diversion/renewal of lease of forest land for mining purposes shall be monitored as per Para 4.16 (ii) & (iii) of the guidelines issued under forest (conservation) Act, 1980;
- 6 There will be regular monitoring by the forest department for compliance of conditions including the quantity extracted;
- 7 The operation of mine should be as per the approved mining plan and user agency shall submit annual self compliance report to the authority concerned;
- 8 Debris will be used locally behind retaining walls depression/improvement of grades. It will in no way be thrown down the hill slope and will also not be thrown in nullahs, etc, and shall be reclaimed;
- 9 Reclamation of mined area shall be done at the cost of user agency as per proposed scheme. Reclamation work will be taken up after the expiry of this extension or if possible, before that in part of the area;
- 10 Demarcation of lease area to be done on the ground at project cost using four feet high reinforced cement concrete pillars with serial numbers, forward and back bearings and distance from pillar to pillar;

- 11 No damage of any kind will be caused to the adjoining forest area and all the protection/ precautionary measures for stability of the forest area be strictly adhered to;
- 12 Safety Zone Area treatment Plan will be implemented as per the proposal;
- 13 NOC from HPPCB and other department/offices shall be obtained by the user agency;
- 14 The forest land will not be used for any purpose other than that specified in the proposal;
- 15 Environment clearance is also to be obtained in this case in view of the Hon'ble Supreme Court order dated 27.02.2012 in IA No. 12-13 of 2011 in SLP (C) No. 19628-19629 of 2009;
- 16 It will be the responsibility of the User agency to obtain prior approval/clearance under all other relevant Acts/rules/Court's rulings/instructions etc. as applicable to this proposal.
- 17 A lease- deed of the forest land shall be executed by the user agency with Collector-cum- Deputy Commissioner, Chamba District Chamba. HP.

The Ministry may revoke/suspend this approval if implementation of any of the above conditions is not found satisfactory. Forest department will ensure fulfillment of these conditions.


