Sub:- Diversion of 0.9927 hectares of forest land in favour of M/s Laxmi Stone Crusher Sanail R/Q V& P.O. Dhar, Tehsil Jubbal, Distt. Shimla, HP for quarry site and constructin of approach road to quarry site, within the jurisdiction of Rohru Forest Division, Distt. Shimla, Himachal Pradesh.

Dhar, Tehsil Jubbal, Distt. Shimla, HP for quarry site and constructin of approach road to quarry site, within the jurisdiction of Rohru Forest Division, Distt. Shimla, Himachal Pradesh को उपयोग के लिए निम्नलिखित शर्ते पूरी करने पर प्रदान की जाती है।

- 1 Legal status of the forest land will remain unchanged;
- No tree felling is involved in the case;
- Compensatory afforestation will be carried out in UPF-Manoo Panu over 2.00 hectares of degraded forest and as per proposed scheme, at a cost of Rs. 2,10,725/-(Rupees Two Lakhs ten thousand seven hundred twenty five only) which is reported to have already been deposited by the user agency. Plantation will be done within one year from the date of issue of this letter.
- This approval is valid for a period of Five years from the date of issue of this letter i.e, upto 05.06.2018.
- The mining is open cast for extraction of slates. No blasting in the area shall be done and no damage will be caused to the adjoining forest area;
- The conditions stipulated while giving approval under the Forest(Conservation) Act, 1980 for diversion/renewal of lease of forest land for mining purposes shall be monitored as per Para 4.16 (ii) & (iii) of the guidelines issued under forest (conservation) Act, 1980;
- 7 There will be regular monitoring by the forest department for compliance of conditions including the quantity extracted;
- The operation of mine should be as per the approved mining plan and user agency shall submit annual self compliance report to the authority concerned;
- Debris will be used locally behind retaining walls depression/improvement of grades. It will in no way be through down the hill slope and will also not be thrown in nallahs, etc, and shall be reclaimed;
- Reclamation of mined area shall be done at the cost of user agency as per proposed scheme. Reclamation work will be taken up after the expiry of this extension or if possible, before that in part of the area;

- Demarcation of lease area to be done on the ground at project cost using four feet high reinforced cement concrete pillars with serial numbers, forward and back bearings and distance from pillar to pillar;
- No damage of any kind will be caused to the adjoining forest area and all the protection/ precautionary measures for stability of the forest area be strictly adhered
- Safety Zone Area treatment Plan will be implemented as per the proposal; 13
- NOC from HPPCB and other department/offices shall be obtained by the user agency; 14
- 15 The forest land will not be used for any purpose other than that specified in the
- Environment clearance is also to be obtained in this case in view of the Hon'ble 16 Supreme Court order dated 27.02.2012 in IA No. 12-13 of 2011 in SLP (C) No. 19628-19629 of 2009;
- It will be the responsibility of the User agency to obtain prior approval/clearance under all other relevant Acts/rules/Court's rulings/instructions etc. as applicable to this proposal.
- A lease- deed of the forest land shall be executed by the user agency with Collectorcum- Deputy Commissioner, Chamba District Chamba. HP.
