

Order

Sub:- Renewal of diversion of 2.00 ha of forest land for an existing mining lease in favour of Smt. Ruma Devi, Prop. M/s Ruma Stone Crusher, Village Parchu, P.O. Sajaopiplu, Tehsil Sarkaghat, within the jurisdiction of Joginder Nagar Forest Division, Distt. Mandi, HP.

- भारत सरकार पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय उत्तर क्षेत्रीय कार्यालय देहरादून द्वारा वन (संरक्षण) अधिनियम 1980 की धारा-2 के अन्तर्गत जारी स्वीकृति पत्र संख्या 9-HPB 791/2005-CHA/2555 दिनांक 04-03-2016 के परिणामस्वरूप राज्यपाल, हिमाचल प्रदेश उपरोक्त विषय में दर्शित 2.00 हैक्टेयर वन भूमि को M/s Ruma Stone Crusher को उपयोग के लिए स्वीकृति निम्नलिखित शर्तें पूरी करने पर प्रदान करते हैं।
- 1 वन भूमि की विधिक परिस्थिति नहीं बदली जाएगी।
- 2 एन.पी.वी. की दरों में अगर कोई बढ़ोतरी होती है तो प्रयोक्ता अभिकरण बढी हुई दरों पर एन. पी.वी. देने के लिए बाध्य होगा।
- 3 प्रयोक्ता अभिकरण द्वारा प्रस्तावित वन क्षेत्र के आस-पास मजदूरों / स्टॉफ के लिये किसी भी प्रकार का कैम्प नहीं लगाया जायेगा।
- 4 प्रयोक्ता अभिकरण के द्वारा निर्माण कार्य के दौरान स्थल पर कार्यरत मजदूरों एवं स्टॉफ के लिए रसोई गैस / कैरोसिन तेल की आपूर्ति की जायेगी, जिससे निकटवर्ती वनों को क्षति न पहुँचे।
- 5 परियोजना निर्माण में उत्सर्जित मलवे का निस्तारण प्रयोक्ता अभिकरण द्वारा प्रस्तुत मलवा निस्तारण योजना के अनुसार प्रभागीय वनाधिकारी की देख-रेख में किया जाएगा एवं निर्दिष्ट स्थानों के अलावा अन्यत्र मलवा नहीं फेंका जाएगा।
- 6 परियोजना के निर्माण व रख-रखाव के दौरान आस-पास के क्षेत्र की वनस्पतियों एवं जीव-जन्तुओं को किसी प्रकार की क्षति नहीं पहुँचायी जायेगी।
- 7 वन भूमि का प्रयोग प्रस्ताव में दर्शाये गये उद्देश्य के अलावा अन्य किसी उद्देश्य के लिए नहीं किया जायेगा।
- 8 प्रयोक्ता अभिकरण अपने व्यय पर आवश्यक मृदा संरक्षण कार्य सम्पादित करना सुनिश्चित करेगा।
- 9 प्रस्ताव के अनुसार कोई भी वृक्षों का कटान / पातन नहीं किया जाएगा।
- 10 The User Agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required, as per the provisions of the Environmental (Protection) 1986.
- 11 Extraction of minor minerals shall be restricted to middle half of the width of river bed after leaving intact the one-fourth of width of the river bed along its each bank.
- 12 To ensure maintenance of river geometry, collection of minor minerals during a working season shall start from centre of the river width and shall gradually extend to the boundary of the permissible area. The maximum permissible depth for collection of minor minerals at centre of the river width shall be limited to 3m and it shall gradually reduce till it reaches boundary of the permissible zone.
- 13 To regulate and maintain record of the quantity of minor minerals extracted during a season, State Forest Department shall set up adequate number of check posts during the collection season.

- 14 Extraction of minor mineral shall be restricted from 1st October to 31st May of the subsequent year.
- 15 Minor minerals shall be collected by manually by using hand tools. Use of explosive and heavy machineries for breaking/collection of minor minerals shall be strictly prohibited.
- 16 Collection time shall be from sun-rise to sun-set.
- 17 The boundary of the forest land being diverted shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, DGPS coordinates, forward and back bearing, and distance from adjoin pillars etc.
- 18 The renewal period of diversion of the said forest land under this approval shall be for a period coterminous with the period of mining lease proposed to be granted under the mines and minerals (development and Regulation) Act 1957, or Rules framed there under. Which is for a period of 15 years from the date of expiry of previous lease period i.e. 23.10.2013 to 23.10.2028.
- 19 The conditions stipulated while giving approval under the Forest (Conservation) Act, 1980 for diversion/renewal of lease of forest land for mining purposes shall be monitored as per Para 4.16(ii) & (iii) of the guidelines issued under Forest (Conservation) Act, 1980.
- 20 There will be regular monitoring by the Forest Department for compliance of conditions including the quantity extracted.
- 21 The operation of mine should be as per the approved mining plan and user agency shall submit annual self compliance report to the authority concerned.
- 22 Debris will be used locally behind retaining walls, depression/improvement of grades. It will in no way be thrown down the hill slope and will also not be thrown in nallahs, etc, and shall be reclaimed.
- 23 Reclamation of mined area shall be done at the cost of user agency as per proposed scheme. Reclamation work will be taken up after the expiry of this extension or if possible, before that in part of the area.
- 24 Safety Zone Area Treatment Plan will be implemented as per the proposal.
- 25 The User Agency and the State Forest Department shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the Project.
- 26 The Ministry may revoke/suspend this approval if implementation of any of the above conditions is not found satisfactory. Forest department will ensure fulfilment of these conditions.
- 27 A lease- deed of the forest land shall be executed by the user agency with Collector-cum- Deputy Commissioner, District Mandi, H.P.
