That an order No. FFE-B-F(2)-2/2016 dated 01-08-2016 was issued by this department for diversion of 2.21 ha of forest land in favour of HPPWD for the construction of link road from Kiri-Banjai (Km. 0/00 to 3/00), within the jurisdiction of Chamba Forest Division District Chamba, H.P.
