Subject:- Renewal of lease of 0.4852 ha of forest land in favour of M/s Orbit Minerals for the purpose of establishment of stone crusher under the jurisdiction of Palampur Forest Division District Kangra, Himachal Pradesh (Online Proposal No. FP/HP/IND/40553/2022)

1. General Conditions

1.1	<ol style="list-style-type: none"> 1. Legal status of the forest land shall remain unchanged. 2. H.P. Forest Department shall upload the KML files of the degraded forest area accepted for raising compensatory afforestation as well as the forest area proposed for diversion in the extant proposal in the E-Green watch portal. 3. H.P. Forest Department shall ensure the compliance of the order of Hon'ble Supreme Court New Delhi issued on 08.02.2023 vide WP (C) No. 202/1995. 4. No muck shall be dumped in the forest land in context of the undertaking submitted by the User Agency. 5. The DFO shall ensure that muck is not dumped in the forest land by User Agency. 6. The forest land will not be used for any other purpose than that mentioned in the proposal. 7. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department, or persons without approval of Ministry of Environment, Forest and Climate Change. 8. The layout plan of the proposal shall not be changed without the prior approval of the Ministry of Environment, Forest and Climate Change.

	<p>9. No damage will be done to the adjoining forest land.</p> <p>10. No labour camp shall be established on the forest land.</p> <p>11. The user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court.</p> <p>12. The User Agency shall provide firewood preferably alternative fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.</p> <p>13. DEO shall ensure that compensatory afforestation will be done within one year from final approval over the extent of land as approved, out of funds provided by the user agency.</p> <p>14. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the direction of the concerned Divisional Forest Officer.</p> <p>15. No additional or new path will be constructed inside the forest area for transportation of construction material for execution of the project work.</p> <p>16. Any other condition that the Ministry of Environment, Forest and Climate Change may stipulate from the time to time in the interest of conservation, protection and development of forests & wildlife.</p> <p>17. It will be the responsibility of the State Forest Department/User Agency to obtain all other prior approvals/clearances under all other relevant Acts/Rules/Court's rulings/instructions, etc. including environmental clearances, as applicable to this proposal.</p>
