Please refer to GoHP letter of even number dated 08.10.2020 on the above mentioned subject vide which conditional Stage-II approval of the Govt. of HP was accorded for diversion of forest land for non-forestry purpose under Forest (Conservation) Act, 1980.

- Now since the Hon'ble Supreme Court of India in its order dated 15.02.2021 has conveyed its approval for the diversion of 0.01 ha. of forest land in favour of I&PH Department, for the use of non-forestry purpose under FCA,1980 and the amount of Compensatory levies has been deposited by the user agency, after careful consideration of the proposal, the Stage-II approval of the State Govt. is hereby conveyed for the above mentioned proposal subject to the following conditions:-
 - Legal status of the forest land will remain unchanged.
 - 2. No tree felling is involved.
 - The forest land will not be used for any purpose other than mentioned in the proposal.
 - 4. No damage of any kind will be caused to the adjoining forest area and all the protection/preventive measures of stability of the area will be strictly adhered to.
 - 5. Muck/Debris generated during the construction, will be properly disposed, and not rolled down along hill slope.
 - 6. The user agency will abide any condition that may be imposed by the State Forest Department in the interest of the protection and development of the forest area.

- 7. It will be the responsibility of the user agency to obtain approval/clearance under all other relevant Acts/Rules/Court's Rulings/Instructions etc. applicable to this proposal.
- 8. This final order is being issued as per the direction/orders of the Hon'ble Supreme Court of India delivered on 15.02.2021 in I.A. No. 191338 of 2019, IA No. 55071, 121109, 130847, 130848 of 2020 in WP (C) No.- 202/1995 titled as T.N. Godavarman Thirumulkpad V/s Union of India & Others.

The Govt. may revoke/suspend the clearance if implementation of any of the above conditions is not satisfactory. The concerned DFO/CF & user agency will ensure fulfillment of these conditions.
