2 Now since the Hon'ble Supreme Court of India in its order dated 15.02.2021 has conveyed its approval for the diversion of 0.243 ha. of forest land in favour of Micro Hydel Project Baggi, for the use of non-forestry purpose under FCA, 1980 and the amount of Compensatory levies has been deposited by the user agency, after careful consideration of the proposal, the Stage-II approval of the State Govt. is hereby conveyed for the above mentioned proposal subject to the following conditions:-

1. Legal status of the forest land will remain unchanged.
2. Compensatory Afforestation will be carried out in UPF Bashar over in 53A/13/SE degraded forest land as per proposed scheme. Plantation will be done within one year from the date of issued of this letter.
3. No tree felling is involved in this case.
4. The forest land will not be used for any purpose other than mentioned in the proposal.
